

Pohick Bay Regional Park Cabin Agreement

Cabin: _____

The following Park Authority Rules apply to the conduct within all NVRPA campgrounds. Campgrounds are to be used in a manner providing for the safety and enjoyment of all. Violation of any of these rules may subject the violator to ejection from the park.

The following is prohibited:

- Smoking is strictly prohibited in the cabins.
- Alcoholic beverages are prohibited in all regional parks.
- No pets of any kind in cabin or on cabin site, except dogs assisting individuals with disabilities.
- Cabin furniture must remain inside the cabin at all times.
- Parties or large gatherings are not permitted.
- Cutting of trees and collecting ground wood is prohibited.
- Profanity, abusive language or behavior and any conduct that may endanger the welfare of any person is prohibited.
- Tents, canopies or recreational vehicles may not be erected on cabin site or cabin parking areas. Service and commercial vehicles, tractors and construction equipment are not permitted.

Check-In/Check-Out

- Check-In time is 1PM. Early check-in is permitted for a charge of \$5 if the cabin has been cleaned and is available.
- Check-Out time is 11AM. Late check-out allows you to stay in the cabin until 7PM and is permitted for a charge of \$10 if no reservation is scheduled. An additional nightly fee will be applied to checkouts past 7PM. There is a \$35 fee for lost or stolen keys.
- During camp store hours campers must register with park personnel, showing valid ID and pay any fees applicable.
- Campers arriving after hours must already have a reservation and must have a valid ID ready to show the night watchman.
- Upon departure, renters must collect all trash, dispose of it in the campground dumpster and sweep the cabin clean. Disposing of trash in the comfort station bathrooms or laundry room is prohibited. Recycle bins are located near the campground dumpster.

Requirements

- Each reservation requires a minimum two-night stay with a two-night non-refundable deposit.
- Maximum stay is seven consecutive days. Renters must vacate the park for four consecutive days before they are permitted to rent a cabin or other campsite again.
- Renter must be 21 years of age or older and a resident of the cabin during the rental period. Renter may not sublet all or part of a cabin rental.
- Cabins are restricted to use by family and individuals only for the purpose of recreational, non-residential overnight accommodations.
- Parties or large gatherings are not permitted.

Guests and Occupants

- Renters must provide their own bedding.
- A cabin is limited to six (6) people. An additional fee will be charged for more than four (4) persons.
- Renters must observe the quiet hours between 10PM and 7AM.
- Guests of renters must pay the appropriate fees, including entrance fees, and must vacate the park at dark.
- A maximum of two (2) motorized vehicles per cabin is permitted in designate parking areas, including but not limited to boats, trailers and vehicles of guests.

Fires

- Open fires, including but not limited to candles, grills and ground fires are prohibited in the cabins or on the cabin porch. Campfires are permitted only in the steel ground pits or fire rings. Grills are for charcoal use only.
- Campfires are not to be unattended. Fires must be extinguished before retiring for the night or departing the cabin site. All fires must be extinguished by 1am.
